TERMS & CONDITIONS

1. Charged per candidate, per subject.*
2. Charged per practical, per subject.**
3. After the final entry closing date we will charge late fees for any new entries you make, as well as for any entry amendments or syllabus changes. Entries or changes received after the published deadlines can cause disruption to carefully scheduled processes and cause significant extra work. Late entry fees are therefore applied to recover the costs of additional processing requirements, and to encourage the submission of entries by the advertised closing dates. Late entry fees will be charged in addition to the normal syllabus fee. Cambridge Assessment International Education (CAIE) may be unable to accept entry changes in the very late entries period if these are received too close to the exam.***
4. Courier costs relating to sending/return of Art are based on items being returned by courier and on work being a maximum size of A2. There may be an additional postage charge if the maximum size/weight is exceeded.****
5. A quote relating to your children's estimated Cambridge examination fees will be sent at the beginning of the school year for payment. Please note that this is only an estimate and may not be the final examination costs due to various changes that may occur during the academic year e.g. swap subjects. It is encouraged that this quote is paid as early as possible to avoid financial pressure prior to final submission date to the CAIE.
6. Examination fees to be paid into the same bank account of the school/campus that the candidate attends, using the same reference assigned for school fees i.e. NAME&SURNAME.
7. Examination fees to be paid in advance of STUDY HOUSE submission of entries to CAIE.
8. In the event that examination fees are not paid in time to STUDY HOUSE based on the published submission date (in order to pay CAIE on time), the prospective candidate will not be registered for their relevant examination entries.
9. Where prospective candidates have outstanding fees on their school account, any monies paid towards examination fees will be utilised against outstanding school fees first.
10. We only refund fees if you let us know about the withdrawal of a candidate before the published entry closing date. We issue refunds after the end of the examination series. If a candidate is withdrawn before the ordinary late entry date, a basic admin fee of R500 will be retained for processing fees. If the candidate is withdrawn after the ordinary late entry date, a basic fee of R500 per subject PLUS 100% of all other fees will be retained.
11. All quotes given will be subject to fluctuations in the foreign exchange rate. Due to the nature of the Pound/Rand exchange rate, an adjustment may be required during the year, in which case an extra invoice may be sent to candidates.
12. Examination fees for STUDY HOUSE candidates as well as external candidates written at STUDY HOUSE is valid between January to November.
13. If specialist access arrangements are requested for which Cambridge approval is required, this is by arrangement only and is dependent on our capacity. Additional invigilation costs may be incurred, please contact us directly at the time of entry for details.
14. Date for full payment of the examination fees into the STUDY HOUSE'S bank account (same as school fees) will fall due and payable on the invoice date.
15. An invoice for entry will be emailed to you for careful checking. Please notify us via email of necessary amendments immediately on receipt of the invoice. We cannot be held responsible for entry errors that should have been identified by you. Errors requiring amendment which are identified after the schools CAIE submission date will incur the late penalty fee so please inform us before that date. Please refer to the STUDY HOUSE Cambridge subject list for the subjects that are offered as exam opportunities.
16. Private candidates are not allowed to enrol for subjects that have a coursework component.
